

# Festival of Cinema Without Barriers: Information Clause on the Processing of Personal Data

## Information Clause on the Processing of Personal Data for Participants of the II Forum Without Barriers

In connection with the applicability of the Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016, on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation - GDPR), we hereby inform you:

1. **The administrator of your personal data is the Centrum Kultury Zamek** with its registered office at Św. Marcin 80/82, 61-809 Poznań, Poland.
2. In relation to the processing of personal data, you can contact the Data Protection Officer designated by the Administrator at the email address: [iod@ckzamek.pl](mailto:iod@ckzamek.pl) or in writing to the address of the Administrator.
3. Your personal data will be processed for the following purposes:
  - a. **To execute the agreement and participation in the II Forum Without Barriers** organized from February 25 to 27, 2025, in Poznań, especially for maintaining contact and informing you about any changes – based on the concluded agreement, i.e. Art. 6(1)(b) GDPR.
  - b. **To fulfill legal obligations** imposed on the Administrator, including tax and accounting obligations – based on Art. 6(1)(c) GDPR.
  - c. **For documentation and information about the activities of CK Zamek**, as well as promotion and advertising (e.g., publication of photos in the press and on the internet on the Organizer's website, and on social media profiles managed by CK Zamek - Facebook, Instagram, etc.) – based on the consent given, i.e. Art. 6(1)(a) GDPR.
  - d. **For the legitimate interests of the Administrator**, such as the pursuit and defense against claims, conducting correspondence – based on Art. 6(1)(f) GDPR.
4. Your data will be processed by authorized employees and collaborators of the Administrator. The recipients of the data will be entities cooperating with the Administrator during the realization of the Forum based on agreements, entities providing IT services and systems for the Administrator, and entities providing property protection services. Your image and statements may be shared for promotional and advertising purposes on the internet (e.g., on social media profiles of the Administrator, the Administrator's website), in the press, and for documenting the Administrator's activities.
5. Your data will not be transferred to third countries (countries outside the European Union or the European Economic Area).

6. Your personal data will be processed for the time necessary to fulfill the purposes of processing, to comply with applicable legal provisions, and until the expiration of any potential claims.
7. You have the right to:
  - a. Access the content of your personal data,
  - b. Rectify, delete, or limit the processing of your data,
  - c. Transfer your data.
8. For data processed based on consent, you have the right to withdraw your consent at any time without affecting the lawfulness of the processing carried out based on consent before its withdrawal.
9. If you believe that the processing of your personal data infringes the provisions of the law, you have the right to file a complaint with the supervisory authority for data protection, which is the President of the Personal Data Protection Office (UODO).
10. Providing your personal data is voluntary but necessary for participation in the Forum.
11. Your data will not be used for automated decision-making or profiling.
